



How Can Your Charity Participate In Charity Challenge XXIII

Charity Challenge was established in 1987 by State Senator Lee Constantine. The concept was to develop an event that would raise funds for Central Florida charities while bringing young adults of our community together in philanthropic activity.

The results have been incredible! In just over a decade, Charity Challenge has evolved from a four-team backyard event, into a multi-media weekend extravaganza with over 100 teams. This year we raised \$300,000 that will be distributed to nearly 90 local charities, bringing our 22nd event total to over \$3 million.

Charity Challenge XXIII will be held on May 17, 2008. Once again this year, the Board of Directors has voted to donate money from the general fund to only those charities that are involved in the event. The more your organization participates, the more rewards you will receive. Your organization can participate in one or more of the following ways.

1. Donate Drawing of Chance Tickets.

Christian Help (Sandi Vidal – 407.834.4022 or sandi@christianhelp.org) will be facilitating the Drawing of Chance Program. He will be responsible for prizes and the printing and distribution of tickets to be drawn at Charity Challenge (tickets will be available for sale now!). Sign up now to be notified when tickets are ready! Each charity will receive as many tickets as they wish and will receive 80% of the proceeds of each ticket (Ex. \$80 for each 100 tickets sold). The more tickets you sell, the greater your donation from the general fund.

2. Recruit a team to participate in Charity Challenge.

Any new team from the apartment, hotel, or hospitality industry is eligible (no team that participated in 2007 may be solicited). Your organization will receive at least 50% of the team's contribution.

3. Recruit a new sponsor for Charity Challenge.

You receive credit for new sponsors only (no sponsor that participated in 2007 may be solicited). Your organization will receive at least 50% of the sponsor's contribution.

4. Help provide goods/services and/or volunteers for the event.

Ex. Registration tables, volunteers, basketball hoops, etc...
